Individuals may enroll in school, on-the-job training or skills training and apprenticeships that enhances their prospects in finding work in emerging or growth industries.

ARPA Cluster (CFDA 21.027). Pacific Mountain Workforce Development Council was awarded as a sub-award under the American Rescue Plan Act (ARPA) Coronavirus State and Local Fiscal Recovery Funds (SLRF) from Thurston County, WA. These funds were used to support the workforce and nonprofits in recovery activities including employment support programs. These grants were used to work with Community Based Organizations (CBOs) to provide meaningful job opportunities to local persons who are unemployed or underemployed.

4c (Code:) (Expenses \$ 1,041,354 including grants of \$ 696,729) (Revenue \$ 1,111,798)

WIA National Emergency Grants (CFDA 17.277). This program responds to the COVID-19 crisis by providing subsidized disaster relief employment, work-based learning, training services, a unified system, and providing coordinated access to career services.
